Join us for the 2<sup>nd</sup> annual PAELA Conference at the Omni Bedford Springs Resort in Bedford, Pennsylvania. The conference agenda is not yet finalized, but will be a series of moderated discussions on substantive, practice management and public policy topics. There will not be any formal presentations; rather this will be an opportunity to discuss important issues with other practitioners. Topics will include litigation updates, annuities, DRA compliant notes, trusts, federal court cases involving special needs trusts, effective use of software, the benefits of Facebook, Twitter and other online networking services, and much, much more.

**Date and time:** The meeting will be held from 8:00am until 5:00 pm on Saturday, February 27, 2010, at the Omni Bedford Springs Resort in Bedford, Pennsylvania. A continental breakfast will be served at 8:00am, followed by the first session at 8:30am.
